In addition to continuing to respond to 150-200 calls and attending 20 to 25 meetings with families each month, Families as Allies continued to expand its reach to include families of young children (birth to five) beginning to show signs of having social and emotional challenges.

The organization was awarded the contract to develop the state Department of Mental Health's Parent Peer Support Curriculum which will allow the organization to expand its outreach regarding family-driven care and how families can navigate the various child-serving systems for their children. Families as Allies formalized its own leadership

training curriculum for families and began regularly offering leadership training and conducting town halls with families around the state. Two fathers from the organization developed and piloted fatherhood leadership training. Town Halls focused on unmet needs in the mental health and education systems and how families believe these needs can best be met.

The organization launched its new interactive website that includes a much broader array of information for families and other stakeholders as well as the capacity to survey families about a variety of issues. The organization finished building its database to track much more information about trends and the strengths and needs that families identify within the child serving systems. The database also allows for sharing of information across systems and organizations in order to build partnerships.

2) SUPPORTING COMMUNITY:

Fifty clinicians went through intensive training for two days each month with national experts to learn evidence-based approaches to support children birth to five and their families so this area of expertise could be available to children that need it.

We strengthened our presence in the juvenile justice system by serving on the Juvenile Justice Task Force and helping to develop community-based options for youth who would otherwise be incarcerated

and outreach to their families. We were a partner with One Voice and the NAACP in their preventing the Schoolhouse to Jailhouse pipeline coalition. We also coordinated with the newly formed Child Protective Services Department to discuss family-driven support for families in the child welfare system.

The organization collaborated with Alignment Jackson to support family engagement in the activities of Jackson Public Schools and assisted Jackson Public Schools with its Special Education self-review team.

All of these efforts enhanced the work with Help Me Grow, a new Kellogg funded initiative led by Mississippi Families for Kids to establish a one-stop shop for parents of young children to find resources and also to ensure those resources are coordinated with each other.

3) SUPPORTING POSITIVE CHANGE AND REFORM:

Mississippi continued to face multiple legal challenges around its mental health system this year. The organization has attempted to use these challenges as opportunities to bring about meaningful reform. In November 2015, Families as Allies issued recommended terms of a settlement agreement that would be most beneficial to children and families and save the state expensive legal costs. Although the release received wide spread attention and endorsements locally and nationally, the organization was not able to engage policy makers to work with the organization to pursue the organization's recommendations. No settlement was reached and the Justice Department sued Mississippi about its mental health system in August 2016. The

organization continues to reach out to the state about working together to bring about the needed changes.

In the Fall, the organization polled all of the statewide candidates in the last election about various issues related to mental health and published an electronic information guide (no endorsements) for all of our stakeholders. This guide was well received and opened up continued conversations and collaboration with policy makers.

The biggest policy effort was with MS Parent and Training Information Center, the ACLU, and Parents for Public Schools which helped lead a collaborative effort among many organizations for the Mississippi Department of Education to develop a Restraint and Seclusion policy, given that Mississippi was one of only five states without such a policy. This led to surveying a large group of families, generating public comments from many stakeholders, and two public hearings. The Department of Education worked closely with families throughout the process. This large grassroots effort brought attention to family driven advocacy and was well covered by local and national media, including the Atlantic and the Marshall Project.

Joy Hogge, the executive director of Families as Allies, was nominated to the board of the Family Run Executive Director's Leadership Association (FREDLA), in this role she had the opportunity to be in a group of family leaders who met with the executive leadership of the Substance Abuse and Mental Health Services Administration to discuss the important roles family run organizations play in responsive mental health systems. She was also chosen to present at the national Annual
